REMINDERS

- **Check with your Adviser for additional requirements.**
- Programs are first reviewed for the **EPSY core course requirements**. Petitions for course substitution for **core area requirements** must be noted and justified on an INTERNAL PETITION form.
- Next, the Supporting or Related Fields portion will be checked. This is considered to be all coursework with other than EPSY designator taken in addition to the core requirements, which provide an area of focus or depth to the graduate program. Course credits for a single course may be counted as either core course credits or supporting program/minor credits, or both.
- Committee members need to sign the **Examining Committee Consent Form** indicating their agreement to serve on the committee; whether as internal or external member; their Grad School status (Associate or Full). In lieu of an actual signature, an email sent to you agreeing to serve will be accepted. For faculty members holding appointments in more than one department, the form must state in which field their expertise is requested.
